

DISCUSSION ITEMS:

1. **Approval of November 17th Meeting Notes.** Ken Henderson moved to approve the November meeting notes; Melissa Halstead seconded; the vote was 4-0-0 to accept.
2. **Holliston Rail Trail Photographs.** Michael Heath showed a collage of trail photographs, taken in October, on his laptop to the Committee members. Mike will place them on his website and Melissa Halstead will create a link to it from the HTC website.
3. **CSX Purchase and Sale Agreement.** Holliston has signed the agreement, and Sherborn will sign their P&S Agreement to purchase their portion of the trail, and their agreement will be packaged with Holliston's for presentation to CSX.
4. **Assorted Trail Signage.** Robert Weidknecht proposed to order signage addressing privacy issues and motorized vehicle use in the amount of \$325.00 to be acquired from the REI Grant. Nik Parrish moved that the purchase be made; Ken Henderson seconded the motion; the vote was 5-0-0 for approval.

5. **Upcoming Trail Cleanup.** The next trail cleanup was discussed by the Committee members and was agreed to be held on Sunday, January 23rd at 12:00 noon to 3:00 pm. The participants will meet at the Village Plaza off Hwy 126 to clear the section behind the plaza.
6. **Conservation Commission Filing.** The Conservation Commission will review the Trails Committee filing at their December 21st meeting.
7. **Trail Use Regulations.** A concern was expressed on the wide variations between town committee regarding the public use of town lands and trails. Ken Henderson agreed to make contact with other committees within Holliston to identify where different rules and files exist.
8. **Town Counsel Services Invoice.** An invoice in the amount of \$ 217.50 for services rendered on the CSX Purchase and Sale Agreement was presented to the Committee from the Town Counsel for review and payment approval. Nik Parrish moved to accept and pay; Ken Henderson seconded; the vote was 5-0-0 for payment from the DCR Grant.
9. **January 2011 Trails Committee Meeting.** The next meeting has been scheduled for January 19th (Wednesday) at 7:00 pm in the Holliston Town Hall.
10. **Meeting Adjournment.** Ken Henderson motioned to adjourn the meeting; Melissa Halstead seconded; the vote was 5-0-0 in favor. The meeting was adjourned at 8:20pm.
