- a. Grade School Pollinator garden: Carrie update New date is July 27 for constructing and plant the garden. Landscaper will submit an invoice for blocks when finished.

- c. Community Garden: PJ update Significant maintenance will be needed this fall (October). An estimated \$1000 necessary for materials: The 10 foot boards are rotted out, more chicken wire is needed to keep out woodchucks and rabbits.

## a. Farm Day

i) Brochure/posters: Cherie Brochure approved with addition of 2 farms, change name to "Holliston Farms Day" (Community Farm periodically holds a "Family Farm Day") and change time under Farmers Market to "closes at 2pm"

PJ will talk to Martha about setting up an AgCom booth at the popup farmers market. AgCom agreed it would be appropriate to have some literature to hand out, to remind people the AgCom exists, that Holliston is a right-to-farm town, and what this means to those living in Holliston. Possible points of focus for the literature:

Identify where people could "buy local"

How to get help if starting up a farming effort (hobby or professional)

Where to go if there is a problem with living in a right-to-farm community

Preserve land, preserve pollinators, right to farm, and potentially the upcoming town vote on acquiring farmland

AgCom could also collect names/email addresses of those interested in receiving the AgCom newsletter. PJ will be manning the booth and requested a way to collect emails (clipboard and sign-up sheet).

- ii) Cherie will send the modified brochure to all farmers on the list and to Martha. They will have 2
  weeks to make changes before the posters need to be printed and put up (approximately 6
  weeks before the event)
- iii) The sign stakes for advertising Farms Day need to be replaced. Cherie will get estimates.

#### Celebrate Holliston

- i) Basically same as Farms Day: there will be a booth, selling milkweed seed, literature, sign-up for newsletter.
- ii) Carrie offered some lavender product if the AgCom is interested in a drawing or giveaway to encourage more community participation.
