- BOA signed Report of Motor Vehicle abatements dated 02/01 02/06/12 for \$1120.00.
- K. Peirce reported on a call from the newspaper on appraiser Dan Dargon. P. Barbieri had abstained.
- BOA discussed abatement application #1 and letter explaining the reason for denial. Letter to include data correction resulting in \$100 reduction in value.
- K. Peirce reported on discussion with other communities who suggested companies provide proposal. K. Peirce recommends appraisal to be paid for by applicant. P. Barbieri stated his opinion to use established formula with actual SREC and give 10% reduction. K. Peirce dealing with state to determine value but typical land values appraiser would review proposal. J. Cronin commented SREC flat formula speculative. B. Loughlin thinks we should do appraisal to establish value of Personal Property cap rate (discount rate). J. Cronin asked about appraisal. P. Barbieri said if no cost to Town he has no objection. P. Barbieri stated K. Peirce should tell company of his position on formulas and discount. K. Peirce to have scope of appraisal work. Public Comment: Tom Gilbert—SREC \$400 per many data bases. Some only deal with value of power.
