## Holliston Board of Assessors April 4, 2017 8:00 am Selectmen's meeting room #105

The meeting of the Board of Assessors was called to order at 8:00 am. Present were: Peter Barbieri, Vice Chairman; John Cronin, Clerk; and Kathryn Peirce, Principal Assessor.

- The BOA briefly discussed the BOA status in light of Mr. Loughlin's recent resignation. The BOA will not reorganize. Current roles will be maintained with Mr. Barbieri as Vice Chairman and Mr. Cronin as Clerk.
- BOA approved the 2016 Motor Vehicle Commitment for \$36.56 and the 2017 Motor Vehicle Commitment for \$179,033.79.
- BOA approved Report of Motor Vehicle Abatements dated 3/31/17.
- BOA approved Report of Exemptions dated 3/31/17.
- Approved Earnings Worksheet for Pay Period Ending 3/24/17, 3/31/17, and 4/3/17.

- BOA approved Meeting Minutes of 3/21/17. Motion by John Cronin, Seconded by Peter Barbieri. All in favor.
- BOA invokes rule of necessity to approve meeting minutes of 3/16/17. Mr. Loughlin has resigned and Mr. Cronin was not present. Mr. Barbieri approves with Mr. Cronin. Motion by Peter Barbieri, Seconded by John Cronin. All in favor.
