The meeting convened at 5:02 PM in Room 105. Present were: Board members: Peter Barbieri, chair, Mary Greendale, and Jeffrey Marshall. Staff: Kathryn Peirce and Kevin Rudden.

- 1. Mary Greendale made a motion, seconded by Jeffrey Marshall, to approve the March 1, 2022 regular session and executive session meeting minutes as written, with authorization to make the executive session minutes public. The motion carried 3-0-0.

Seconded by Jeffrey Marshall, to approve the wording of the draft Annual Town Meeting warrant article to petition the state legislature to pass a home rule law allowing Holliston to implement a Means-Tested Real Estate Tax Exemption, and to submit the article to the Town Administrator. The motion carried 3-0-0.
- 7. Board members briefly discussed the scheduled meeting with the Finance Committee at 7 PM on March 8, 2022 to discuss the board's proposed Fiscal Year 2023 budget. Peter Barbieri will not be able to attend the meeting, and Mary Greendale will speak on behalf of the board.
