6. Kevin Rudden asked the board to support giving Kathryn Peirce a contract to assist the Assessors' Office after she retires in early May. Peter Barbieri said the board supports the idea, since the funds were earmarked in the proposed Fiscal Year 2023 budget. Execution of the contract is Travis Ahern's responsibility.
