<u>Eagle Scout Project: Trail Mapping at Daniels Land, Poitras Land and Mellen Street</u> Conservation Area: *Connor Wood*

- Mr. Wood presented his project to the Commission. He proposes to map and mark trails on these parcels, as they are currently not well marked. He would also like to build a kiosk at the entrance to the Mellen Street Conservation Area.
- Mr. Wood compared the Commission's maps to those found on AllTrails, which were better marked than the Commission's. He suggests merging the two to make a comprehensive map.
- Ms. Pilch noted that some trails are on private property. Mr. Wood noted that a vetting of the trails is appropriate to determine if they are public or private. Mr. Lively suggested signage marking and restricting access to private property.
- Mr. Lively inquired as to how Mr. Wood would mark the trails. Mr. Wood plans to use plastic
 markers and mounting them. Ms. Pilch expressed concerns that metal and plastic signs often
 are improperly installed, resulting in the tree growing around them. Mr. Bajdek suggested Mr.
 Wood research best practices for trail markings.
- Mr. Wood discussed fundraising, suggesting that he could reach out to local businesses and individuals for donations in return for naming a trail. Ms. Pilch expressed that this constitutes a conflict of interest, but instead the kiosk could note all those who have contributed to the project.
- The Commission approved Mr. Wood's proposal and thanked him for his offer.

Discussion: Article XXX Regulations

- Mr. Clapp discussed options for reviewing the Article XXX regulations. After speaking with Ms.
 Greendale, he suggests a Google Doc edited by the Commission, noting that for Open
 Meeting Law compliance the Commission needed to be on Zoom during the review.
- Mr. Lively expressed concerns about the efficiency of this option. The Commission agreed, noting that this does not seem to be any better than the first review.

- Ms. Pilch suggested editing manageable portions of the regulations per meeting, similar to what was previously done but with less material each review. The Commission found this to be a better option.
- Mr. Clapp will divide the regulations and send out the portion to be reviewed at the 12/22 meeting.

Discussion: Conservation Land Rules

 Mr. Clapp presented draft Conservation Land rules to the Commission, noting that there had only been camping rules previously. The Commission offered various minor edits for clarity.

Ms. Pilch made a motion to approve the rules for Conservation Lands. Dr. Rutberg seconded the motion. A roll call vote was taken.

Tree Removal Request: #54 Turner Road

- Mr. Clapp noted that this request was for two large pine trees located outside the 50' buffer zone, but within the 100' buffer zone. These trees had split trunks near the bottom, and the weight of growth was starting to crack the trunks where they split. There is significant die-off near the top of the tree and it is currently shedding large branches.
- Mr. Lively inquired if stump grinding was proposed. Mr. Clapp noted that a standard condition
 was to prohibit stump grinding. Ms. Pilch noted that with the trees so far from the wetland and
 within existing lawn, she had no concerns with stump grinding. The Commission agreed with
 this assessment.
- The Commission approved the tree removal request.

Request for Certificate of Compliance: DEP #185-856: #7 Liberty Lane

Mr. Clapp reported that this project was for a single family house. Since the project was within
the 100' no disturbance buffer zone to vernal pools, there was significant mitigation required.
The project has been constructed in compliance with the Order of Conditions, with the only
item outstanding is the final certification of the vernal pool. He noted that NHESP is currently
backlogged, and the pool is approved for certification.

Ms. Pilch made a motion to issue a Certificate of Compliance for DEP #185-856: #7 Liberty Lane. Ms. Weissman seconded the motion. A roll call vote was taken.
