Public Hearing – Review and Implementation of Proposed Regulations for the Town of Holliston Wetlands Protection Bylaw (Article XXXI)

- R. Clapp read the legal advertisement into the record.
- The Commission reviewed the draft regulations section by section. These regulations had been reviewed and revised thoroughly by the Conservation Commission during previous public meetings, and had been reviewed by Town Counsel.
- James Read, 45 Pleasant Street and 2016 Washington Street, expressed concerns regarding the proposed building setbacks, and that the general public was unaware of these regulations being proposed. R. Clapp noted that the building setback was to ensure that the 50' No Disturbance Zone, established under Article XXXI, is not degraded by building immediately

However, he noted there is an entire section of waivers in the event this regulation creates an undue hardship. He also noted that it is more difficult to impose regulations than it is to amend them, and that if this regulation is found to be inappropriate, it may be amended. He also noted that the requirements for notification under the Open Meeting Law were met.

• Nicole Smith, 176 Hollis Street, expressed support for the proposed regulations, agreeing that further protection for wetland resource areas must be established, noting the amount of recent development in the Town.
