# Request for Certificate of Compliance for DEP File No. 186-793: 186 Locust Street - Gustavson Development LLC

Mr. Gustavson requested a Certificate of Compliance for DEP File No. 186-793: 186 Locust Street and submitted an As-Built Plan: %Broposed Septic System, Gustavson Development LLC, 186 Locust Street, Holliston MA, dated 25 November 2014, revised through 10 April 2015 (As-Built). The Agent visited the site on June 16<sup>th</sup> and found the project site to be completely stabilized and the grass has been mowed twice. There will be two Ongoing Conditions regarding snow removal and pesticide/herbicide use.

## Automatic Extension via The Permit Extension Act and Plan Change Review for the Order of Conditions for DEP File # 185-657: Lot 189 Indian Ridge Road South

Applicant: Nicholas C. Torti, Lot 189 Indian Ridge Road South, LLC

Mr. Torti submitted a plan, Resource Area Plan of Land in Holliston, MA+dated Rev. 5/19/15, annotated June 18, 2015 with change in house footprint. This lot has a new owner and the house footprint has been shrunk 7qon both sides, from 24qx 64q to 24qx 50q The applicant is asking for an administrative review of these changes to the Order of Conditions.

## <u>Agricultural Commission – Update on Rogers Road Farm</u>

- Tony Lulek and Paula Marks attended the meeting to provide an update regarding the Rogers Road Farm.
- The Agricultural Commission (AgCom) approves of bee hives on the east end of site
- The AgCom is going in front of the Selectmen tomorrow night to get approval to form a non-profit organization for the Rogers Road Farm. The non-profit would lease the land from the Town, hopefully, for a low price (e.g., \$1.00), which is what the Medway Community Farm does in Medway.
- They need a structural engineer to review the structural integrity of the house on the farm property. AP Associates uses a structural engineer and Mr. Katuska will give this info to Mr. Lulek.
- The electricity is on in the house and there is oil in tank.
- The hope is to find a farmer to possibly live on the property to run the farm. Dennis and Kristen Serocki live on the farm property next door, so the AgCom would like to put up a fence on the property line so that they wond be disturbed.
- Rolf Briggs and Marc Connelly have been asked to be on the Advisory Board.
- The ConCom will send a letter of support for the AgCom to the Selectmen for tomorrow nights meeting.

• Weston Pond Dam - Vegetation Management
