Meeting Minutes

June 26, 2018

The meeting convened at 7:00pm in Room 105 at Holliston Town Hall. In attendance: Chairperson Ken Szajda, Vice Chairperson Michelle Zeamer, Clerk Ben Sparrell, Sue Nersessian, Dan Alfred and Vincent Murphy. Absent: Tim Maxwell.

Mr. Moles from the Board of Health answered questions about a line-item transfer for his department. The transfer was to pay an employee who had exceeded scheduled hours. Mr. Szajda asked if this put the employee over 20 hours and thus eligible for benefits. Was this approved by the Board of Selectmen? The Committee requested details about the employee¢ hours for the year to determine if benefits would need to be presented. Ms. Nersessian asked if the employee was paid. Mr. Moles indicated they were and would answer the other questions as quickly as possible.

Ms. Zeamer made a motion to approve Finance Committee Secretary, Nancy Farrells hours. Ms. Nersessian seconded, and the motion was passed 6-0.
