Town of Holliston Finance Committee

Meeting Minutes

April 16, 2019

The meeting convened at 7:00pm in Room 019 at Holliston Town Hall. In attendance: Chairperson Ken Szajda, Vice Chairperson Michelle Zeamer, Clerk Ben Sparrell, Sue Nersessian, Vincent Murphy and Dan Alfred. Absent: Tim Maxwell

Library Director Leslie McDonnell addressed the Committee regarding the request for funds in the amount of \$10,000 for consultant services to develop a library building program document that would articulate the library's vision of the future and serve as a set of instructions to the architect.

Upper Charles Conservation Association member Dawn Durning Hammond presented budget and investment return information on the proposed position for a Sustainability Coordinator for Holliston. Topics discussed included how the position might be shared with Sherborn; other communities that have hired sustainability coordinators; the opportunity for public education on climate change issues; and how to move forward with a citizensqpetition. Ms. Durning-Hammond emphasized their perspective that there is a critical need to move forward on these issues. The committee asked for the text of the motion be provided for review to understand what was being requested.

The next topic of discussion was the proposed Facilities Manager position within the Department of Public Works. Committee members expressed concern that the position has not yet been clearly defined. Mr. Szajda said that there has long been a need for such a position, but that it needs to include the schools. Mr. Alfred suggested taking the \$85,000 salary out of the budget and sending a letter to the Board of Selectmen to request more clarity.

Mr. Szajda reported that without the \$85,000 for the Facilities Manager position the budget's bottom line was \$174,256. The Committee discussed the amount of local aid that might be available from the State. The Committee considered departmental requests from the Library, the Rail Trail Committee, the School Department and the Police Department. Mr. Alfred suggested the Committee recommend the funding of an additional police officer and \$100,000 in additional funding to the School Department for two priorities. Mr. Alfred highlighted the impact of contractual obligations on other needs.

The Committee proceeded to voting on their recommendations on departmental budgets:

Ms. Nersessian made a motion to recommend the request for \$301,855 for the Board of Selectmen's FY2020 budget. Mr. Alfred seconded the motion and it was passed by a vote of 6-0.

Ms. Nersessian made a motion to recommend the request for \$2,310,392 for the DPW/Water FY2020 budget. Mr. Alfred seconded the motion and it was passed by a vote of 5-1, Mr. Murphy dissenting.

Ms. Nersessian made a motion to recommend the request for \$477,535 for the. Ambulance FY2020 budget. Mr. Alfred seconded the motion and it was passed by a vote of 6-0.

Ms. Nersessian made a motion to recommend the request for \$12,673 for the Economic Development Committee's FY2020 budget. Mr. Alfred seconded the motion and it was passed by a vote of 6-0.

Ms. Nersessian made a motion to recommend the request for \$2,000 for the Celebrations FY2020 budget. Mr. Alfred seconded the motion and it was passed by a vote of 6-0.

Ms. Nersessian made a motion to recommend the request for \$250,000 for the DPW/Snow and Ice FY2020 budget. Mr. Alfred seconded the motion and it was passed by a vote of 6-0.

Town Accountant Sharon Emerick reported that a discrepancy had been found in the Accountant's Office budget that was being corrected. Mr. Alfred suggested reducing the capital Expenditure Fund contribution by \$50,000 to make up the difference.

Ms. Nersessian made a motion to reconsider the recommendation for the Accountant's Office. Mr. Alfred seconded and the motion passed by a vote of 6-0. Ms. Nersessian made a motion to recommend the request for the Accountants budget at \$173,356 and the Treasurers budget of \$383,406. Mr. Alfred Seconded the motion and it was passed by a vote of 6-0.

The Committee voted on their recommendations for Warrant Articles:

Ms. Nersessian made a motion to raise and appropriate \$1,237.46 to pay unpaid bills as mentioned on Article 6: Pay Unpaid Bills. Mr. Alfred seconded and the motion passed by a vote of 6-0.

Ms. Nersessian made a motion to recommend indefinite postponement on Article 7: Current Fiscal Year Transfers. Mr. Alfred seconded and the motion passed by a vote of 6-0.

Ms. Nersessian made a motion to recommend favorable action on Article 8: Authorize Board of Selectmen to Sell Surplus Equipment on. Mr. Alfred seconded and the motion passed by a vote of 6-0.

Ms. Nersessian made a motion to recommend favorable action on Article 9: Authorization to Expend Chapter 90 Funds. Mr. Alfred seconded and the motion passed by a vote of 6-0.

Ms. Nersessian made a motion to recommend favorable action on Article 10: Revolving Fund Spending Limits. Mr. Alfred seconded and the motion passed by a vote of 6-0.

For Article 11, Ms. Nersessian made a motion to make a recommendation that the exemption remain at 20%. Mr. Alfred seconded and the motion passed by a vote of 6-0.

Ms. Nersessian made a motion to recommend favorable action on Article 12: Circuit Breaker Income Adjustment to Deferral Applicants. Mr. Alfred seconded and the motion passed by a vote of 6-0.

Ms. Nersessian made a motion to recommend favorable action on Article 13: Amend Interest Rate Per Annum. Mr. Alfred seconded and the motion passed by a vote of 6-0.

Ms. Nersessian made a motion to recommend favorable action on Article 14: Amend Income Requirements. Mr. Alfred seconded and the motion passed by a vote of 6-0.

Ms. Nersessian made a motion to recommend that the Town raise and appropriate \$1,750,000 for the capital expenditure fund (Article 16). Mr. Alfred seconded and the motion passed by a vote of 6-0.

Ms. Nersessian made a motion to recommend the Town vote to appropriate \$963,483 from the Capital Expenditure Fund to fund the purchase of the following items:

Ms. Nersessian made a motion to recommend that the Town appropriate \$600,000 from Water Retained Earnings for Water Treatment Plant. Mr. Alfred seconded and the motion passed by a vote of 6-0.

Ms. Nersessian made a motion to recommend the Town raise and appropriate or transfer from available funds \$10,000 for Article 22: Library Consultant. Mr. Sparrell seconded and the motion passed by a vote of 5-0, Mr. Alfred abstaining.

Ms. Nersessian made a motion to recommend for favorable action on Article 23: Solar Panels at Landfill. Mr. Alfred seconded and the motion passed by a vote of 6-0.

Ms. Nersessian made a motion to recommend indefinite postponement on Article 25: Blair Square Improvements. Mr. Alfred seconded and the motion passed by a vote of 6-0.
