Parks Commission Meeting Wednesday February 8, 2017

Minutes of January 11th were reviewed. Mr. Chipman made a motion to accept the minutes of January 11th. Ms. Daniels Seconds. ALL IN FARVOR. Mr. Winters abstains.

1750 Update

Mr. Ritter updated that it would be six weeks until the elevator will be finished. That brings us to April 1st. Mr. Tartakoff is going to meet with Mr. Clinton and Ms. Hedrick to review the room use and occupancy limits.

Budget

The Parks Board has to re-approve the budget that is being presented to the Finance Committee on February 14th. Mr. Winters makes a motion to approve the FY18 budget:

Appropriation of \$103,194

1% cost of living increase

Director \$47,918.62 x 1% = \$479.1862 + \$47,918.62 = \$48,397.81+\$200 longevity=\$48,597.81

Assistant Director See below for steps* \$41,088(32 hours)

Grounds \$24.86 x1%=.2486 + \$24.86= \$25.10 per hour times 10 hours times 52 weeks=\$13,052

TOTAL: \$102,719.81

Allocated: \$103,194-\$102,738.81=**\$456.19**Mr. Chipman seconds, ALL IN FAVOR

Mr. Chipman makes a motion to approve the request for 8 additional hours to the Assistant Parks & Recreation Director position for the FY18 presentation to the Finance Committee as follows:

40 Hours a week:

\$24.20x 40 hours=968 x 26.4 weeks = \$25,555.20 \$25.20 x 40 hours =1008 x 25.6 weeks =\$25,804.80

Total of: \$51,360

We are looking for an additional:\$10,272 \$51,360(40 hours) minus \$41,088(32 hours)=\$10,272 For a total budget of \$113,466.00 Mr. Winters seconds, ALL IN FAVOR.

Ms. Hedrick asked if it could be done by April vacation week. Mr. Chipman said that would be the goal before the kids started walking downtown.
