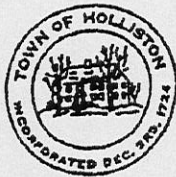

QUESTION 1:

Shall the Town prohibit the operation of marijuana retailers, as defined in Massachusetts General Law Chapter 94G, Section 1?
