# BOARD OF WATER COMMISSIONERS NOVEMBER 13, 2013 MEETING ROOM 014

MEETING began at 6:00pm.

### **WATER BILL DISPUTES**

The Board discussed water bill disputes for the following addresses:

21 Birchwood Road

5 Meadowbrook Lane

23 Francine Drive

121 Rolling Meadow Drive

151 South Street (Corinne, daughter of deceased owner)

169 Cedar Street (Ralph Finos)

The Board evaluated the water history of each property and the repairs made by homeowners after discovering leaks, and made the following motions:

Mr. Keating made a motion: õMotion to cap the bill at 21 Birchwood Road at TIER2 and the Office Staff will re-compute the bill for April/May/June 2013"

Mr. Antonioli seconded the motion.

Mr. Keating and Mr. Antonioli voted in favor of the motion.

Mr. Keating made a motion: õMotion to cap the bill 5 Meadowbrook Lane at TIER1 and the Office Staff will re-compute the bill for April/May/June 2013"

Mr. Antonioli seconded the motion.

Mr. Keating and Mr. Antonioli voted in favor of the motion.

Jared Adams, Steve DeFrancesco, and Jay Leary arrived at 6:05pm.

Mr. Keating made a motion: õMotion to cap the bill 23 Francine Drive at TIER2 and the Office Staff will re-compute the bill for April/May/June 2013"

Mr. Antonioli seconded the motion.

Mr. Keating, Mr. Adams and Mr. Antonioli voted in favor of the motion.

Mr. Keating made a motion: oMotion to cap the bill 121 Rolling Meadow Drive at

TIER3 and the Office Staff will re-compute the bill for April/May/June 2013 with the notation that if it occurs again, it will be at the prevailing rates"

Mr. Antonioli seconded the motion.

Mr. Keating and Mr. Antonioli voted in favor of the motion.

Mr. Adams voted against the motion.

Mr. Keating made a motion: õMotion to cap the bill 151 South Street at TIER2 and the Office Staff will re-compute the bill for April/May/June 2013"

Mr. Antonioli seconded the motion.

Mr. Keating, Mr. Adams and Mr. Antonioli voted in favor of the motion.

The homeowner daughter left at 6:20pm.

Ralph Finos of 169 Cedar Street asked for relief for his bill of April/May/June 2013. When he was informed by the Board that the cost for testing his meter was \$95.00, he decided there was no sense in testing it when his relief would result in a \$50.00 reduction of his bill.

Mr. Finos left at 6:45pm.

The Board said that the water used in renovating the house at 377 Highland Street was in TIER1. There have been no leaks found. The option of paying \$95.00 for a meter test will be offered to the homeowner. A new meter had been installed when the house sold in May 2013. A Service Call has been scheduled for November 20, 2013.

The bill for April/May/June 2013 has been paid in full for 1865 Washington Street. The last contact with the homeowner was July 29, 2013. No payment was made on the July/August/September 2013 bill which was due on November 15, 2013.

Mr. Keating made a motion: õMove that the late date be extended to December 1,2013

To these homeowners who have a change in the cap in
Their water bills"

Mr. Antonioli seconded the motion.

Mr. Adams, Mr. Antonioli, and Mr. Keating voted in favor of the motion.

Mr. Adams left at 6:50pm.

The Board discussed the bill dispute process and decided that the Office Manager will negotiate with homeowners and Mr. Valovcin will have final approval of negotiations. If the homeowner requests an appearance before the Board, the meter will have been tested **prior** to the Board meeting.

Mr. Leary left at 6:58pm.

Mr. Keating made a motion: õMotion that the Water Superintendent be granted authority to resolve disputed bills based on appropriate diagnostic activities and that these caps will be determined by corresponding prior billing periods"

Mr. Antonioli seconded the motion.

Mr. Antonioli and Mr. Keating voted in favor of the motion.

# WATER TREATMENT PLANT #4 – PROJECT

Steve DeFrancesco of AECOM, project engineers for the project, had submitted a contract amendment for signatures. Mr. Keating expressly asked if this was the õlast oneö to which Mr. DeFrancesco answered õyesö. Mr. Valovcin announced that the project is being wrapped up and the system is now running.

Mr. Keating made a motion: õMotion that we accept and sign Amendment #5LS between Town of Holliston and AECOM Technical Services"

Mr. Antonioli seconded the motion.

Mr. Antonioli and Mr. Keating voted in favor of the motion.

Mr. Antonioli and Mr. Keating signed the document.

There will be a balance of \$15,500.00 after this bill process is completed.

#### WELL #4

Well #4 is running into the system. Mr. Valovcin has reviewed all tasks that still need to be worked out with Steve DeFrancesco.

The Board acknowledged the letter from the Department of Environmental Protection. Mr. Valovcin announced that he is no longer õprimary operatorö for the Town of Holliston due to his promotion to Water Superintendent. Currently three employees are legally able to operate the plant, but one is retiring at the end of January 2014.

Mr. DeFrancesco left at 7:40pm.

## **WELL #7 PROJECT**

Well #7 is running with good run time from the filters. Trees have been installed, seeding is completed, swing gates should be installed soon.

Mr. Valovcin suggested that the Board withhold some of the payment from DeFelice because the grass seed was put in so late in the season ó it may not take hold and would need to be re-seeded in the Spring.

#### **CEDAR STREET METER PIT**

Mass Installation pulled the meter out completely. Gauges need to be put in before the end of November. Mr. Valovcin plans to put in flowable fill during the Winter season.
