Mr. Valovcin said that a reduction in anyoness salary will affect the morale of the department. Stipends had already been denied for two of the Water Systems Operators this month. The Water Superintendents salary is being reduced by more than \$8,300.00 from FY14 to FY15 by the Board of Selectmen. The reduction will result in his salary being **lower** than the salary of the Highway Superintendent who does not have licenses for CDL, Water Distribution (D4) and Water Treatment. Mr. Antonioli said that the reduction in salary to a level lower than the Highway Superintendent to be unacceptable.

The Finance Committee liaison for the Water Department, Bill Dowd, has not been responded the e-mails from Mr. Valovcin. Mr. Dowd has not met with any of the Board of Water Commissioners during the current Fiscal Year.

The Board of Selectmen never mentioned that they were meeting on the Water Department FY15 budget at their March 26, 2014 Board of Selectmen meeting.
