The meeting of the Board of Assessors was called to order at 8:00am. Present were: Brian Loughlin, Chair, Peter Barbieri, Vice Chair, John Cronin, Clerk, Kathryn Peirce, Principal Assessor and Don Clarke, Assistant Assessor

The Board acted on the following:

- Approved mileage reimbursement for Mr. Clarke for August and July totaling \$127.98 and \$42.12 respectively.
- Approved payment of \$80.00 for Mr. Clarke's attendance at Oct. 20th MAOO Fall conference.
- Approved payment of \$80.00 for Ms. Peirce's attendance at Oct. 20th MAOO Fall conference.

- BOA directs Ms. Peirce to fully value 4 lots on Prentice/Mill St. (284.9, 28.5, 284.7 and 28.3). Lot 284.8 at partial completion. On Kingsbury fully value 5/3.54.A, 5/3.54.3, 5/3.54.B and 5/3.55.4. On Highland fully value 123.8, 123.7, 164.6, 164.5, 123.4 and 123.5. Percent of completion all remaining but 123.1 and 123.2(these have houses). On Concord fully value 3.4.5. For Toll Bros. (Hiawatha and Gov. Prence) fully value all noted pink and yellow highlighted properties. Underwood/Anna Place full value on 5 lots (52.2, 51.2, 51.3, 51.4 and 57.5).
