THE TOWN OF HOLLISTON'S COMMUNITY CHOICE POWER SUPPLY PROGRAM CONSUMER NOTIFICATION

The Town of Holliston is pleased to announce that **Constellation Energy** ("Constellation") has been selected as the supplier for its Community Choice Power Supply Program ("Program"). Constellation will provide electric power supply for all Basic Service consumers in Holliston. This notification is intended to tell you about this Program for electric power supply. In accordance with state law, it also informs you of your rights and options if you choose not to participate in the Program.

YOU WILL NOT NOTICE ANY CHANGE IN YOUR ELECTRICITY SERVICE. The only difference you will see is that Constellation will be printed under the "Supply Services" section of your monthly bill. You will continue to receive one bill from Eversource Energy (formerly NSTAR). You will continue to send your payments to Eversource Energy for processing. Eversource Energy will continue to respond to emergencies, read meters and maintain the distribution and transmission lines. Reliability and quality of service will remain the same. Furthermore, you will continue to have all existing consumer rights and protections.

You will automatically be enrolled and start benefiting from the lower rate beginning on the day of the month in January 2016 that your meter is read. This date varies by service area. Your meter reading date is shown on your bill.
