## **COMMENTS FROM THE BOARD**

Mr. Conley said that he went to the last Community Center Task Force meeting and they discussed where they wanted to go. He said that the Committee found property on Summer Street and they thought that it would be perfect. Mr. Conley said that it is premature at this point. He said that there are questions that need to be answered first. He said that there is more work to be done in that regard. He said that it was a great property but the timing is wrong. Mr. Conley said that the Committee is going to refocus and come back with more definitive answers. He said that he thinks that this will be a two to three Committee event. He is asking the Committee to come before the Selectmen in November to give a presentation.

Mr. Leary said after Town Meeting. Mr. Conley said that he did not think that they would be ready for Town Meeting. Mr. Leary said that the building is very impressive but there are still a lot of questions out there.

There were no comments from the audience.

License transfer Bertucci's

## PLANNING BOARD - DOWNTOWN INTERSECTION STUDY

Mr. Leary said that they asked the Planning Board to rank the four vendors that put in their bids for the traffic intersection study. Mr. Leary said that this started last fall when they did an audit with the state. He said then the request for proposal (R.F.P.) was ready to go out.

Mr. Leary said that after the ranking, they chose McMahon and Associates. Mr. Leary said that they have done work in Sherborn, Natick and Newton. Mr. Leary said that they are familiar with the Metrowest area.

Mr. Le Beau said that after the Planning Board ranked each vendor they opened up the price proposal. He said that because there was a big pricing discrepancy between number one and number two, they advised the Planning Board and the Planner that there was this discrepancy and the issue was the additional eight or nine thousand dollars for the top ranked firm and if it was justified in terms of added value. Mr. Le Beau said that there are only a few points between them.

Mr. Le Beau said that the Town Planner said that it made sense to go with the seconded ranked vendor of McMahon.

Mr. Le Beau said that we had a free analysis from the State, but it did not give us any direction on what or where to go.
