John Greendale, Highland Street, is very concerned about potholes. He said that he has been collecting all the hot top that comes out of the pothole at the end of his driveway on Highland Street and is keeping it in a 5 gallon pail. He said that he getting to old to be picking it up. He said that this past summer the pothole was dug up and re-patched and it keeps breaking up. Mr. Greendale would like the Highway Department to take the broken patch with them when they come to patch the hole. Mr. Marsden said that when you have a lot of patch at the end of your driveway, call the Highway Department and they will come and pick it up. Mr. Greendale said that the roads are falling apart with age. Mr. Leary said that this winter has been tough on the roads.

YOUTH AND FAMILY SERVICES BUDGET REQUEST

Margaret Fitzpatrick, Director was present to discuss her budget. She is happy to report that they had low numbers for the court diversion program. She said that they went from 45 to 8 this year. She said that it can happen like that from year to year. She said that there were many community service hours put in. They were able to place them at the Recycling Center, Senior Center, Town Hall and the Food Pantry. She said that they have been able to help with fuel assistance this year. She said that they are working with the schools to pinpoint high risk kids. She said that they can maintain the current level she said that there is more need than they can give.

COUNCIL ON AGING BUDGET REQUEST

Lina Arena-Derosa, Director and Carmen Chiango were present to discuss the budget. Ms. Arena-Derosa wanted to thank the Highway Department because they have been able to stay open with all the bad weather that we have had. She said that they plow, shovel and sand and salt the parking lot and the steps. She said that they could not stay open without them. Ms. Arena-Derosa said that starting on March 4th they will be open on Tuesday evenings until 8:00 p.m. She said that they have many programs that they want to run at night. She said that in keeping in line they went with a 1% increase in salary. She said that everyone who comes in gets a card and they swipe it as they enter that way they will have an accurate number of visitors. She also said that they are going to have portable devices for the bus and van. She said that would be starting in March. Ms. Arena-Derosa said that van traffic is very busy she said that as the days get colder and icy residents want to be picked up and not drive themselves. She said that they will be asking for a reserve fund transfer in the spring to keep up with the needs for the van.

Mr. Chiango said that one of the vans will be out of warrantee soon. Ms. Arena-Derosa said that the MWRTA can service most of the vans and buses. She also said that they will be having an intern for three months and she will be helping them put all their information on the Town's web-site. She also spoke about the parking issue. She said that they have 55 parking spots and they would like 20 to 30 more. She said that the Town Planner and the Tree Warden have been very helpful. She said that they have already spoken with the Conservation Commission. She said that the front stairs are falling apart and they need to be replaced. She has Keefe Tech coming to look at them for replacement. She said that they will take care of the ramp as well. Ms. Arena-Derosa said that the job descriptions continue to grow and she is hoping that their salaries can. She said that they would like to hire more staff because of the additional hours that the Center is open. Ms. Arena-Derosa said that at the spring Town Meeting it was approved to put a new roof on the Center. She said that we have had so much snow it still is not done. Ms. Arena-Derosa said again that they need more help. She said that there is a lot of paperwork that needs to be done for the State and the Town and more staffing would help. She said that in the next 5 years they will need a new dishwasher, stove, oven and refrigerator. She also said that the bathrooms need to be updated. She also said that to have bigger classes they would like to take down a wall and put up a false wall that can be opened and closed in case the office space was needed. Mr. Leary asked about the van issue. How do you identify the costs by the Center. Ms. Arena-Derosa said by driving around. Mr. Leary asked how much does a ride cost? She said that she has no idea, she will figure it out and let him know. Mr. Le Beau said that a ride costs about \$10.00. Ms. Arena-Derosa said that if they have a program going on and we have a problem with the van or

weather, they have a sign up list and they call everyone to let them know that something has come up.
