# **COUNCIL ON AGING FORMULA GRANT**

#### **BLUE WAVE SOLAR PROJECT – CHESTNUT STREET**

Simone Zaglia, the Blue Wave Solar Project Representative, was present. He said that they attended our last meeting in June to give permission to Verizon to move a pole on Chestnut Street. He said that there were a few residents at that meeting and they said that work was starting before 7:00 a.m., and was creating a lot of noise. Mr. Zaglia said that he wanted to review his notes.

Mr. Marsden said the residents were concerned about the impact in the development.

Tanya Corbett, 11 Wedgewood Drive said she is an abutter to the solar project. She said that they are supportive of the project. She said that they would not be able to see the solar panels. She said that they were shown pictures with mature trees and you could not see the project. She said that the trees are not mature that were planted and you can see it from their property. She said that this was going to be a one phase project, but now there is a phase II. Mr. Zaglia said this is not entirely a different project. He said that it is an expansion. He said that because this is an expansion, the grading will be heavy. He said that the only other traffic would be the panels going into place. He said that they have to be finished by February 2015. He said it will take about 120 business days to set the panels. Ms. Corbett said that the trucks have been showing up at 5:00 a.m. and the air breaks make a lot of noise. She said that sometimes there is more than one waiting to be unloaded. Mr. Zaflia said that they would speak to the contractor. Mr. Zaglia said that he was told that the tree line was agreed upon when the project was discussed. He said that he would be more than happy to take a look at it.

Mr. Marsden said that it may not be trees they might need a fence. Something big. Ms. Corbett said that they are considering selling. Ms. Corbett said that this project took out a line a trees that were not to be removed. Mr. Zaglia apologized to the Corbetts on the contractors behalf.

Mr. Conley thanked Mr. Zaglia for coming to the meeting.
