AGRICULTURAL COMMISSION

Tony Lulek and Andy Reseska were present to talk about the Serocki property. Mr. Lulek said that Mr. Reseska is a bee keeper and would like to put his hives on the Serocki property. Mr. Lulek said that it was voted at a meeting to rent the property at \$100 for the first year. He said that they would be revisiting this again.

Mr. Marsden said that this is a six month vote for the bees to stay on the property. Mr. Reseska said that they are a home base operation and it is in Holliston. Mr. Reseska said that they are always looking for locations to house the bees.

Mr. Marsden said that he thinks it is a good idea.

Mr. Lulek said that they would also like a community garden on the property. He said that it would be part of the property and would be a non-profit.

Mr. Leary asked if there was a budget for the property? Mr. Lulek said no because they have not had any expenses. Mr. Conley said that he thinks that the Serocki property will be self-supporting. Mr. Lulek said that it was suggested by the Medway Community garden that when they lease out space it is for five to ten years. Mr. Lulek said that they would also have to have educational programs. Mr. Leary said that there should be budget for the property. Mr. Lulek said that would come once they have a business plan in place.

Mr. Lulek and Mr. Reseska are going to put together a plan for the property and the Board will review it.
