COMMENTS FROM THE BOARD

Mr. Leary thanked everyone who attended Town Meeting last week. He said that he is very happy that they were able to get everything done in two nights. He said that there is still an Article that needs to be finished #30 the downtown project. He said that there is a ballot question for this at the Annual Election. He said that if that passes, then they can go for funding. Mr. Leary said that this was passed at Town Meeting by a wide margin and he is hoping that it passes on the ballot. He said that this is a reminder to get everyone out to vote.

Mr. Marsden thanked everyone who attended Town Meeting. Mr. Marsden said that he is pleased that they moved the Planning Board Articles up in the Warrant. He said that there were a lot of people who got to hear and listen to it. He said that it was much better than doing it at the end of the night.

There were no comments from the audience.

REPORT OF THE TOWN ADMINISTRATOR

Mr. Ritter said that he has several up-dates. He said that he has a check in the amount of \$147,000 as part of the Green Community Program. He said that there was a meeting today with Eversource, World Energy and Kelly Brown from the Green Communities Program. He said that they have been reviewing the projects that were coming up in the next few months. They created a time line. He said that improvements will be a Central Street Fire Station, Town Hall and the Police Station.

Selectmen's Meeting Minutes

Mr. Marsden asked for a photo to be taken.

Mr. Ritter said that they will be looking at almost \$27,000 in annual savings in energy. He said that Eversource has \$34,000 in incentives. He said that these projects will be finished by October. Mr. Ritter said that this will give us the opportunity for go after additional funding.

Mr. Ritter said that the driving range at Pinecrest has new nets. He said that there is a pending retirement for the Conservation Agent, Chuck Katuska. He said that he has a plan in place for replacing him. He would like this position filled by August 1, 2016.

Mr. Ritter said that the renovation project at 1750 Washington Street is coming along. He said that he has met with the contractor and the Architect. He said that there are a few minor details that need to be worked out. He said that it is his hope that the Selectmen will have a contract to sign at next week's meeting.

He said that the improvements at the Senior Center are coming along. He said that they had \$100,000 to start and they have used \$75,000. He is expecting everything to be completed by June 30, 2016.
