Present: Jay Leary, Chairman; Jay Marsden, Clerk and Jeff Ritter, Town Administrator. Kevin Conley, Vice Chairman was absent.

7:00 P.M., TAX CLASSIFICATION HEARING

Mr. Marsden read the hearing notice

Present: Brian Loughlin, Chairman of the Assessors and Principal Assessor Katheryn Peirce. Absent were Peter Barbieri and John Cronin.

Ms. Peirce said that a decision needs to be made on the tax rate. Should it be a single tax rate or should all business be taxed the same as a home?

Ms. Peirce said that the Town does give a discount to agricultural properties.

Ms. Peirce said that the Board of Assessors supports a single tax rate.

MR. MARSDEN MOVED TO ADOPT A SINGLE RESIDENTIAL TAX RATE OF 1%. THE MOTION WAS SECONDED BY MR. LEARY. TWO IN FAVOR. MR. CONLEY WAS ABSENT.

MR. MARSDEN VOTED NO ON A RESIDENTIAL EXEMPTION. THE MOTION WAS SECONDED BY MR, LEARY. TWO IN FAVOR. MR. CONLEY WAS ABSENT.

MR. MARSDEN VOTED NO ON A SMALL COMMERCIAL EXEMPTION SUBJECT TO THE RECOMMENDATIONS OF THE BOARD OF ASSESSORS. THE MOTION WAS SECONDED BY MR. LEARY. TWO IN FAVOR. MR. CONLEY WAS ABSENT.

MR. MARSDEN VOTED NO ON THE OPEN SPACE DISCOUNT. THE MOTION WAS SECONDED BY MR. LEARY. TWO IN FAVOR. MR. CONLEY WAS ABSENT.

AT 7:20 P.M., MR. LEARY MOVED TO CLOSE THE HEARING. THE MOTION WAS SECONDED BY MR. MARSDEN. TWO IN FAVOR. MR. CONLEY WAS ABSENT.

PAYMENT IN LIEU OF TAXES AGREEMENT – MARINA ENERGY LLC

Mr. Loughlin said that there was a pilot agreement for the solar panels. He said that they depreciate in value. Mr. Loughlin said that the Town will get \$32,000 per year for 20 years. And, if they add more solar panels, the Town will get more money for that.

Mr. Leary asked what if the company goes out of business?

Ms. Peirce said that they did have another company that filed bankruptcy and they sold all their energy to another company. So that group is not paying the taxes.

Mr. Leary asked if they were bound by the same pilot agreement or do they have to renegotiate again?

Ms. Peirce said that they have not had to renegotiate, they are honoring the agreement.

Mr. Marsden said that all that information would be in the contract.

Mr. Ritter said that Town Counsel has reviewed the documents and approved it.

Mr. Ritter said that he sent out the lease extension to Johnson Golf for the management of Pinecrest. Mr. Ritter said that this is a two year extension that the Board approved.
