Mr. Conley said that Bill Mayer has retired as our Town Counsel. He has served Holliston for many years. Mr. Conley said that the Board has signed a proclamation for Mr. Mayer. The Board thanked Mr. Mayer for all his hard work and dedication to the Town of Holliston.

Mr. Mayer thanked the Board for all their kind words.

REPORT OF THE TOWN ADMINISTRATOR

Jeff Ritter, Town Administrator, was present. He said that last week, he met with the 8 Arch Bridge Committee. They are working on an invitation to bid on this project. Mr. Ritter said that the 8 Arch Bridge Committee will be joining the Selectmen on August 7th at a meeting.

He said that a host agreement with 29 Everett Street is the next step for this growing facility. He said that Town council is reviewing the agreement.

Mr. Ritter said that the Flagg School demolition project the environmental portion work has been completed. He said that it is a clean building. He said that Eversource has removed an underground transformer from the site. He said that all the electricity has been shut off to the building. He said that the demolition is starting on Wednesday, July 26, 2017. He said that the final landscaping will be at the end of August.

Mr. Ritter said that last week we received a grant from Mass Office of Disabilities in the amount of \$30,000. He said that this is for work being done at 1750 Washington Street. He said that on August 7, 2017, he is going to ask the Board to open the Warrant for the Special Town Meeting. He said that the Special Town Meeting will be on October 23, 2017.

Mr. Ritter said that last week we opened bids for the down town light project. He said that we received nine bids. He said that McMahon and Associated are reviewing the bids.

Mr. Ritter said that Town Council hours will be on Thursday, August 3, 2017, at 11:00 a.m. He said that Robert Weidknecht from the Trails Committee has an appointment to talk about encroachment onto the trail by property owners.

POLICE DEPARTMENT STRATEGIC PLAN

Mr. Conley said that Chief Stone is present to talk about the five year Strategic Plan.

Chief Matt Stone said that he emailed everyone the plan. He said that this is a follow-up from the plan that was first put in place in 2012. He said that this is the second five year plan. He said that there was a community survey online that they were able to collect data from. He said that over one thousand residents took this survey. He said that they focused on five things, traffic, juvenile, community relations, crime prevention, and domestic violence and mental health. He said that this plan will take the Department to 2022. He said that every focus area has a team leader. And at the end of the year, a report will be given to the Chief.

Mr. Conley asked if down Town traffic concerns was high on the list?

Chief Stone said yes number 2 or 3.

Mr. Ahronian said that drug awareness is high on the list. He asked if they should have a second school Resource Officer (SRO)?

Chief Stone said that they could use an extra SRO. He said that being able to talk to the younger kids will help.

Mr. Conley said that mental health issues are growing.

Chief Stone said that they have a part-time clinician who shares her time with Ashland, Hopkinton and Sherborn. He said that they are seeking a full time Mental Health Clinician. He said that he thinks that this will be a common practice for other Police departments.

Mr. Ritter congratulated Chief Stone on all the work that was done on this. Chief Stone said that several members of the Department were involved in creating it. He said that it was a team effort. Mr. Ritter asked about the plan and the accreditation.

Chief Stone said they are almost side by side. Chief Stone said that the Department will be fully accredited on August 14, 2017. He said that they will be one of only a handful that are accredited. The Selectmen thanked Chief Stone.

ANDREWS SCHOOL REQUEST FOR PROPOSALS

Mr. Ritter said that he has a draft for the sale of the Andrews School at 17 School Street. He said that Town Meeting gave the Selectmen authority to dispose of the property.

Mr. Ritter asked that the Board approve this so that it can be advertised. He said that he would like a response date of Friday, September 8, 2017 at noon. Mr. Ritter said that there are a few zoning changes

Mr. Conley said that last time there was not a lot of interest.

Mr. Ritter said that we did have a couple of contractors that were interested, but they did not submit anything.

Mr. Conley said that with the zoning change, now they can put three house lots on the site.

Mr. Ritter said yes the zoning has changed in the Mudvill area of Town. He said that it is now Village Residential. He said that we are still waiting for the Attorney General to approve it.

Mr. Ahronian asked if someone just wanted to purchase the building and refurbish it, they could.

Mr. Ritter said that it is possible.

MR. AHRONIAN MOVED TO APPROVE THE SCHEDULE FOR THE ANDREWS SCHOOL PROPOSALS. THE MOTION WAS SECONDED BY MR. MARSDEN. ALL IN FAVOR.

TOWN COUNSEL FEE SCHEDULE

Mr. Ritter said that there are two ways to pay Talerman, one is per the hour and the other is a monthly retainer. Mr. Ritter said that in each one of you has a package with the breakdown.

Mr. Ritter said that we just received out first bill in the amount of \$1,200. He said that this going to be a learning curve. Mr. Ritter said that there is a great need for Town Counsel. He said that land use has several issues. Mr. Ritter said that he is leaning towards a retainer instead of hourly billing.

Mr. Ahronian asked if it could be reviewed every year?

Mr. Ritter said that they could review it every six months or whenever you would like to.

Mr. Marsden said that he would like more clarification. He said that it looks like we will be getting about 20 hours of service from them. Mr. Marsden said that the Town does not have its own legal department.

MR. MARSDEN MOVED TO AUTHORIZE THE FLAT FEE OF \$3,500 PER MONTH FOR TALERMAN, MEADE AND COSTA, WITH A REVIEW AFTER ONE YEAR. THE MOTION WAS SECONDED BY MR. AHRONIAN. ALL IN FAVOR.

Mr. Ritter said that this is only for basic services. This does not include litigation.

COMMON VICTUALLER'S LICENSE

MR. MARSDEN MOVED TO INVOKE THE RULE OF NECESSITY TO APPROVE THE UP COMING LICENSE. THE MOTION WAS SECONDED BY MR. AHRONIAN. ALL IN FAVOR. (MR. CONLEY AND MR. AHRONIAN ARE LIONS' CLUB MEMBERS).

Ms. Lacoss said every 911 emergency is different. She said that she has a great ability to go into a situation and calm it down and then come to an agreement. She said that she likes undercover work.

Mr. Marsden asked if Ms. Lacoss was an EMT?

Ms. Lacoss said no she is not.

Mr. Marsden asked if she would be willing to become an EMT?

Ms. Lacoss said yes.

Mr. Marsden asked what do you love about your job, and what do you hate about your job.

Ms. Lacoss said that she loves the people that she works with, and she loves the people that she sees on a daily basis. She said that she likes to make connection with people. She said in her job there is always something new, it is never boring.

Ms. Lacoss said that what she does not like is that the equipment is not up to date. She said that her radio has gone down several times and you need a radio.

Mr. Conley asked what it your most interesting story?

Ms. Lacoss said that they had a man that went into the woods and they could not find him. She said that they did not have a K9 so she went to utube and pulled up barking dogs, and put it over the loud speaker of the car, and he came out of the woods.

Ms. Lacoss thanked the Board for their time and she would really love to work in Holliston.

- Mr. McLaughlin thanked the Board for their time and consideration.
- Mr. Conley said that police business is very interesting. Mr. Conley said that the Board has a tough decision to make. Mr. Ahronian said that Mr. McLaughlin has more experience than Ms. Lacoss, but he really liked her. He said that she has a different skill set than Mr. McLaughlin has. He said that his choice is Ms. Lacoss.
