Downtown Discussion: J. Ritter briefed the Committee regarding the status of the Washington Street Corridor Improvements Project. The project appears to be on schedule to be completed by June 30th. Industrial Parks: P. Barbieri said there was a recent open house at the newly established Herb Chambers Collusion Center in the New England Industrial Park. There is a scheduled Public Hearing with the Planning Board regarding 375 Hopping Brook Industrial Park for this evening.

Discussion Marketing Brochure and Local Permitting Guide: The Committee reviewed the Marketing Brochure and made several suggestions. P. Barbieri will communication to the Town Planner.

Budget Payment of Bills: J. Ritter reviewed the Annual Town Meeting Warrant. The budget for the EDC is intact and there should not be any revisions. The most important Article on the Water is the Water Treatment Plant.

Other Business: M. Coletti said he had two (2) ideas. First, is about vacancy fees for buildings that have been vacant for several months because the rent is too high.
