#### 7. Other appropriate Business to come before the board

a. DHCD notice regarding Town Appointed Tenant Board Members Hayley, this notice is relevant to the next open seat not the open seat that I am on the ballot for this year. There was a lot of questions that a lot of Towns had. On March 1<sup>st</sup> DHCD released an Addendum Number 1 (Frequently Asked Questions). Very first question asked was about the Spring 2021 election. It basically says if the seat that is up is the traditional seat, on the ballot, not because someone resigned that that seat should go forward with town election process. And that the next open seat would be the seat that is available for the tenant board member.

Our next open seat is 2023 which is Commissioner Dumas and Commissioner Malone. However, Commissioner Malone does not count because he is State appointed.

Paul, so the tenants have 2 years. We do not have an LTO. The decision when choosing to fill the Town Appointed Tenants Board Member is the Towns decision. Tenants at Local Housing Authorities with no LTO can submit their own names to the Town for consideration. When the time comes, we will post in the common areas and send a notice out to all tenants regarding the available seat and the process.

#### 8. Residents

Jane and Cindy are here. Cindy, is there a possibility of us getting new furniture for the living room in the Club House, legs keep breaking off the couch and Kelvin keeps fixing. They are very old. Paul, if someone wants to take the lead and come to me with what you think you need; we will look into it and see the cost. Big long wait on furniture at this time. Cindy, Habitat for Humanity they donate. Will the light be put back on flag pole? Paul said yes. Cindy and Jane, so good to see all these things

getting done.

The tenants requested a vacancy report be part of the monthly meeting. Hayley agreed. We will have a vacancy report each month for now on.

Paul, we had our vaccine clinic, I feel it was successful, vaccinated about 45 had 90 ready to go. Many went elsewhere. It was well received, Keegan, Suzanne and Ryan did an excellent job. Marty from the Senior Center was there, it went over well. Tenants: you are doing a good job, all of you, we appreciate it.
