

Minutes of the Holliston Open Space Committee

September 12, 2023, 7:30pm

Lixy Carey called the meeting to order at 7:32pm and read the following statement:

Parks and Recreation is looking into the possibilities for a park on the site.

Ms. Loscocco and Ms. Pilch are co-administrators for the account and have been posting photos taken at conservation land around town.
