Dear Mr. Sousa:

I'm writing to inform you that Holliston Asphalt & Concrete, Inc.'s ("Company") Recycling, Composting or Conversion ("RCC") Permit, transmittal number X267053, with the effective date of June 6, 2018, has expired as of June 6, 2023. Via email messages to your colleague, Henrique Oliveira, on both December 13, 2022 and March 10, 2023, I informed Holliston Asphalt & Concrete, Inc. of the pending expiration date of the RCC Permit and the need to file an RCC Renewal application if the Company wishes to continue operating beyond the June 6, 2023, permit expiration date. MassDEP did not received an application to renew the RCC permit from the Company.

In accordance with section V.I. Operation Interruption, of the RCC Permit (enclosed), if the Operation is discontinued the Operator shall, promptly and in a timely manner, notify MassDEP of the discontinuation, and as deemed necessary, remove, recycle, or dispose of any/all materials, waste materials and products from the Operation and/or Site in accordance with all applicable regulations, including, but not limited to: 310 CMR 16.00 and 310 CMR 19.000.

As of June 6, 2023, the Company is no longer allowed to operate as a recycler of asphalt paving, brick, or concrete ("ABC") rubble (i.e., cease all receipt and processing operations) and shall remove from the Site all materials associated with the operation previously permitted under the



RCC permit, including all processed and unprocessed ABC materials as well as any waste materials.

To ensure the proper removal and disposition of all materials from the Site, the Company is required to submit to me in writing, at the letterhead address, by June 28, 2023, a cleanup plan ("Cleanup Plan") for written approval that will provide for the expeditious removal of all materials from the Site. The Cleanup Plan shall include, but not necessarily be limited to: an updated Site Plan prepared by a Massachusetts licensed land surveyor that shows the piles of onsite ABC materials with estimated volumes; a description of the cleanup procedures to remove the materials from the Site without creating nuisance conditions (e.g., excessive noise and dust); and identification of the disposal/recycling facility or facilities proposed for shipment of all materials generated from the cleanup activities.
