Constitution Village ó Construction Deadline

Present with Atty. Paul Beattie were Mike Harrington, Project Manager from FRE Building and Dale MacKinnon, PE of Guerriere & Halnon to provide an update on the Phase II work associated with the Modification approved in October 2018.
