CONTINUED PUBLIC HEARING: Special Permit and Site Plan Review Bartzak PVI, LLC 103 Bartzak Drive

The Chair reopened the hearing at 7:17 p.m. and explained the hearing format, noting that the applicant will present, followed by questions and concerns by the members and then questions and concerns from the audience. Present along with Adam Maynard of Galehead/Bartzak PV I, LLC was Atty. David Berson as well as Devin Howe, Pat Connolly, and Bryan Sutherlin of Beals Associates. Mr. Howe gave a Powerpoint presentation primarily based on correspondence dated January 5, 2023 from Beals Associates and questions raised at the prior hearing session. He noted that Canavaugh Tocci had been engaged to produce a noise study. Atty. Berson noted he had spoken with Atty. Winner and would be putting the applicant's position on the Dover Amendment protections and the parcel's split zoning into writing for the next hearing session.
