

Weekly COVID-19 Report

When the DPH published the updated town by town information this evening, our community risk designation remained at the YELLOW (moderate risk) level, based on new cases in the 14 day period ending April 17. According to their weekly reports, our numbers lowered from 17.2 Average Daily Incident Rate per 100,000 on April 15 down to 16.7 Average Daily Incident Rate per 100,000 on April 22. Our percent positivity raised from 2.37% the previous week up to 2.59% for the period ending April 17.




Looking at our 58 active cases, they are spread over 43 addresses. There are eleven clusters at single family homes, one cluster at multi-family dwellings, 26 individual cases at single family homes, and five individual cases at multi-family dwellings.

According to vaccination data by community released by the state, 59.4% of the population is partially vaccinated, and 35.5% of the population is fully vaccinated as of April 20. As of the report 97% of the 65-74 age group, and 100% of the 75+ age group had received at least 1 shot.



According to an analysis of MAVEN data, the largest increases in cases in the past week were in the 30-39 (5%), 60-69 (4%), and 0-9 and 50-59 (3%) age ranges. There were no new cases in the 20-29, 70-79, 80-89, and 90+ age ranges this past week.







On Tuesday April 20, the Emergency Management Director provided the following *CARES Act* spending breakdown to the Select Board. The chart represents municipal spending, and does not reflect expenses charged to the ESSER or *CARES Act* funds received by the schools. The Planning and Development Expenses do reflect technology purchased by the schools, for which the Select Board had committed municipal *CARES* funding prior to the July 2020 Annual Town Meeting. The amounts indicated are prior to any potential reimbursement for eligible expenses.
