

## Weekly COVID-19 Report

When the DPH published the updated town by town information this evening, our community risk designation remained at the **GREY** level, based on new cases in the 14 day period ending May 22. According to their weekly reports, our numbers lowered from 4.2 Average Daily Incident Rate per 100,000 on May 20 down to 1.6 Average Daily Incident Rate per 100,000 on May 27. Our percent positivity lowered from 0.98% the previous week down to 0.67% this week.




Looking at our 5 active cases, they are spread over 5 addresses. There 5 individual cases at single family homes.

According to vaccination data by community released by the state, 76.7% of the population is partially vaccinated, and 61.6% of the population is fully vaccinated as of May 25. As of the report 100% of the 65-74 age group, and 102% of the 75+ age group had received at least 1 shot. As of this report, data also showed 57% of the 12-15 year olds and 101% of the 16-19 year olds having already received at least one shot.



According to an analysis of MAVEN data, there were new cases in the 0-9, 50-59, and 60-69 age ranges in the last week.







On Monday, May 24, the Emergency Management Director provided the following *CARES Act* spending breakdown to the Select Board. The chart represents municipal spending, and does not reflect expenses charged to the ESSER or *CARES Act* funds received by the schools. The Planning and Development Expenses do reflect technology purchased by the schools, for which the Select Board had committed municipal *CARES* funding prior to the July 2020 Annual Town Meeting. The amounts indicated are prior to any potential reimbursement for eligible expenses.
