If a section of the canal is private property, then the private owner would be responsible for permitting.

Ownership of Lake Winthrop

Lake Winthrop is considered a "great pond" since it is larger than 10 acres. All "great ponds" in Massachusetts are owned by the state; therefore, Holliston does not own Lake Winthrop. The state is in charge of issuing Chapter 91 licenses to permit activities in, on, over, or under the area of a "great pond" no matter if they are larger or smaller than they were historically. These are things such as, docks, floats, retaining walls, beach nourishment, culverts, dams, etc. As the Chapter 91 Waterways website states, Chapter 91 licenses and permits are necessary to protect and promote the public interest in these water bodies by ensuring that proposed projects and activities do not unreasonably interfere with navigation and the rights of the public or adjacent waterfront property owners; protect water-dependent uses and serve a proper public purpose.
