Addition of health insurance for new Water Superintendent (no insurance For current Superintendent)
Addition of sums to handle increase in salary of new Superintendent
Changes to Workman's Compensation figures (tentative for now)
Additional money for Professional Development (due to increases In course costs for licensing)

Additional money for postcards for delinquent accounts

This proposed budget does not include any Capital Expenses which will add a vehicle.

Mr. Sharpin has budgeted for a one percent increase in salaries. This may change if the Field System Operators join a union. Mr. Sharpin cited the following reasons that there might be changes to the proposed budget:

Increase in delinquent bills Unforeseen water main breaks Union bargaining New DEP rules
