Mr. Sharpin was instructed by the Board to send a letter to Rising Tide Development that will notify them that the Water Department will not sell water to the development.

WELL #4

Work on the project continues at Well #4 Treatment Plant.

WELL #6

Mr. Sharpin is awaiting a decision from the DEP concerning their acceptance or rejection of the Water Department's Action Plan for the Well #6 Treatment Plant. He will send an e-mail to DEP requesting the status of the plan.

WELL #7

Work on the electrical conduit at Well #7 project will begin during the week of April 8, 2013.

WATER SUPERINTENDENT SEARCH

Mr. Adams informed Mr. Weise and Mr. Antonioli that he has sent a letter to the Board of Selectmen because the Board of Water Commissioners has not heard from the Board of Selectmen since the Board of Water Commissioners' meeting in March about the Selectmen's interest in the creation of a Department of Public Works in Holliston.

Mr. Valovcin has ordered the tans that will be installed prior to the conversion to sodium hydroxide at Well #5. Delivery is expected in four to six weeks.
