Executive Session Minutes - MR. MCCOLL MOVED, MR. MARSDEN SECONDED AND IT WAS UNANIMOUSLY VOTED TO APPROVE BUT NOT RELEASE THE EXECUTIVE SESSION MINUTES OF APRIL 26, 2011.

Proclamation –Law Enforcement Officers Memorial Day – the Board approved and signed the proclamation for Law Enforcement Officers Memorial Day.

Event Permits – Tri State Trek and Ashland Lions Club - MR. MCCOLL MOVED, MR. MARSDEN SECONDED AND IT WAS UNANIMOUSLY VOTED TO APPROVE THE EVENT REQUEST FROM TRI STATE TREK.

MR. MCCOLL MOVED, MR. MARSDEN SECONDED AND IT WAS UNANIMOULSY VOTED TO INVOKE THE RULE OF NECESSITY.

MR. MCOLL MOVED, MR. MARSDEN SECONDED AND IT WAS UNANIMOUSLY VOTED TO APPROVE THE EVENT PERMIT FOR THE ASHLAND LIONS CLUB.

Constable Re-appointment - MR. MCCOLL MOVED, MR. MARSDEN SECONDED AND IT WAS UNANIMOUSLY VOTED TO RE-APPOINT BARRY SIMS AS A CONSTABLE FOR A THREE YEAR TERM.

Article 31 and Motions - the Board was joined by Labor Counsel, Town Counsel and the Treasurer/Collector. Mr. Mayer, Town Counsel, said that he believed that the petitioner had placed this article on the Warrant as a placeholder. He said that the petitioner would be presenting his motion on the floor and that Mr. Mayer would respond at that time. There was a conversation about collective bargaining with respect to benefits. Mr. Carey, Labor Counsel, said that teachers bargain with the School Committee and the Police Association bargains with the Town. It is the duty and obligation of the Unions to speak for their retirees as well. Non-union and retirees, as far as the Town's contribution rate goes, is an Executive function of the Selectmen. Town Meeting has a funding role after the rate has been set. If the obligation is not funded, it would have to go back to the unions for further negotiation. There was further conversation about the vote of 2001.
