## **METRO-LEC INITIATIVE**

Chief Moore said that this is a great program. He said that they would pick two applicants from the department who would be available for disasters. He said that they

would be trained and the cost of joining is around \$3,000 to join and then \$2,000 per year after that. Chief Moore said that Ashland and Millis are already members. He said that this is something that the State Police are involved with.

## **PWED GRANT**

Tom Smith, Highway Superintendant, was present. He said that the project at East Holliston went through Mass Highway. He said that there are funds available for lights at Washington Street, Woodland Street and High Street. He said there was a two year study on the traffic. Mr. McColl said that if we don't put in the lights and the State comes back and says that we need them, now we will have to pay for them. Mr. Smith said that it will cost about \$80,000 to put the lights in. He said that we have \$62,900 left in the PWED account, and those funds were set aside for the lights. Mr. Smith said that the lights would have to be up by June 30, 2011. Mr. Smith said that everything is there. They would have to put in the pedestal and wire the box. Mr. McColl said that if we do not do this with State funds, then we will have to pay for it ourselves. Mr. Smith said that the residents of East Holliston picked out the pedestals and the old fashion look of the light pole. Mr. Smith said that the lights were a condition of the State when the project started. Mr. Porter said that the residents of East Holliston should be notified. There will be a hearing about this at the May 16, 2011, meeting.

MR. MCCOLL MOVED TO OPEN THE TOWN MEETING WARRANT TO ADD AN ADDITIONAL ARTICLE FOR THE FINANCE COMMITTEE. THE MOTION WAS SECONDED BY MR. MARSDEN. ALL IN FAVOR.

MR. MCCOLL READ AND MOVED TO APPROVE THE FINANCE COMMITTEE REQUEST FOR ADDITIONAL FUNDS FOR AN INDEPENDENT STUDY TO COVER ALL EMPLOYEES WAGES AND BENEFITS. THE MOTION WAS SECONDED BT MR. MARSDEN. TWO IN FAVOR. MR. PORTER ABSTAINED.
