Mr. Conley said that he received an e-mail from a resident congratulating the Board for putting in the traffic light at Washington Street, Woodland Street and High Street.

Mr. Marsden thanked Mr. Le Beau and Ms. Minihan for all the work that they did trying to create a Veterans District, and it has been approved. The Towns are Holliston, Ashland, Medway and Hopkinton.

CUSTOMER SURVEY

Mr. Leary asked Mr. Conley if he has any feed-back on the survey. Mr. Conley said the he has seen a few. Mr. Conley said that employees can use this survey as a learning tool. Mr. Leary asked if the survey would be on paper or online.

Mr. Conley said he would prefer online.

Mr. Leary said that they are planning on putting together a Web-site team. He said that they have three who are interested, but they would like to have five members.

Mr. Leary said that Town Hall is having trouble with the chimneys. Mr. Le Beau said that they are falling apart. He did get a quote verbally, but we will need to get at least three quotes in writing.

Mr. Le Beau said that he meet with the Town Hall Restoration Committee last week just to bring them up-to-date on the condition of the chimneys. He said that the Committee will consider chimney repairs as part of the exterior restoration. It has been suggested that the chimneys come down and new ones built from the roof line up. He did say that would be more expensive.

Mr. Leary said that we are having a problem with some trees in Town that will need to come down.

Mr. Le Beau said that the Tree Warden, Mark Ahronian, Tom Smith and himself went out to look at the trees that are a problem. He said that they should be removed before this winter. He said that some of the trees are on Winter Street and High Street. Mr. Le Beau said that Mr. Smith and Mr. Ahronian will be going out again to do a survey on several streets checking the trees. Mr. Le Beau said that the cost estimate is around \$25,000. Mr. Le Beau said that they will be looking for funding at the October Town Meeting.

Mr. Le Beau said that the Garden Club would like to add to the tree budget. He said they thought around \$5,000 just for pruning.
