Town of Holliston Green Community 4th Quarter Progress Report June 30, 2018

The Town of Holliston Green Community Team continues to be hard at work implementing the remaining three approved projects by the DOER. Below are details of events and processes that have occurred since the last Progress Report.

Project 1: Stand-alone Thermostat (95% Complete – Waiting on Final Invoice)

Project 2: Town Hall Boiler and Pump Replacement (95% Complete – Waiting on Final Invoice)

5-16-2018: FedEx and Dave's Heating and Cooling arrive to deliver the boiler. The 2 boilers are temporarily stored in a conference room adjacent to the boiler room.

6-1-2018: Dave arrives to inspect the boiler room and turn off the current heating system.

6-4 to 6-8-2018: Dave removes the old boilers and gas/vent piping and prepares the work area to receive the new boilers.

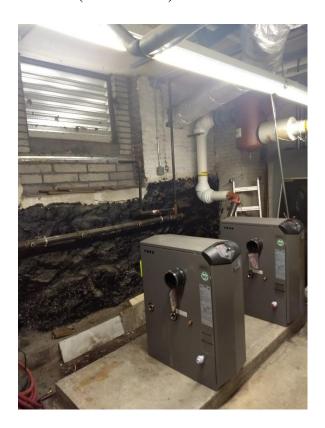
6-11-2018: New boilers are positioned into place (see picture) and permits are pulled for gas and electrical work.

6-18-2018 to 6-22-2018: New boilers are plumbed and electrically tied into heating controller. Testing, final inspections, and signoffs are scheduled for the week of June 25th.

6-24-2018 to 6-29-2018: Work continues on venting and programming the new boilers.

6-29-2018: Boilers are finished with local electrical and plumbing inspectors signing off.

7-2-2018: Completion paperwork signed by the Town and World Energy. Waiting on Final Invoice. (See Attached)

Project 7: Holliston Public Library Lighting and Lighting Controls (80% Complete – Installation in Process.)

5-8-2018 – Holliston reaches out to World Energy (WE) to request an updated financial estimate of remaining lights and a status on a purchase/install time-frame. The response is they are still working on them and the Town does not need this information to proceed.

6-14-2018 – Holliston reaches out to World Energy (WE) to again request an updated financial estimate and time frame to install the remaining lights.

6-27-2018 – World Energy is awaiting more information from Eversource on Utility Incentives. World Energy pulled the non-standard lights out of the original Utility Incentive they applied for figuring they would do a separate request for the non-standard lights. The few lights they now need to finish the project do not qualify for incentives due to the long payback. World Energy is discussing with Eversource that as originally spec'd out these lights belong with the original project and should be viewed as one project and the savings be spread across the entire project.

Project 8: Purchase 2 Electric Vehicles and a Charging Station (**Completed**)

6-27-2018 The Nissan Leaf's go in for their first service as Nissan has issued a voluntary recall on the Lithium Battery Controller as the current software was found not to display an accurate driving range and battery capacity indicator level.

We are excited to state that in the first 9 months both cars have driven a combined 5000 miles. According to afdc.org website, the town, by using 2 electric cars, has saved 294 gallons of gas, decreased our CO2 emissions by 5,796 lbs, and decreased our Fuel costs by \$527 (based upon \$2.67 price per gallon).

Lastly, as word has circulated around town that the chargers are open to the public, many days/nights non-town cars can now be seen charging by the station.
